**ADMINISTRATIVE ORDER
2024-05**

Idaho Court Administrative Rule 62(c) provides: “The questions contained in the qualification questionnaire must be limited to those which elicit answers that may disqualify a person from jury service. ...; **provided however a supplemental administrative questionnaire addressing questions which are developed for administrative purposes only may be used if approved by the Administrative District Judge.**” I.C.A.R. 62(c) (emphasis supplied).

Rule 62(d) provides: “**A supplemental voir dire questionnaire addressing questions which are developed for the purpose of voir dire may be used if approved by the judge assigned to the case or the Administrative District Judge.**” I.C.A.R. 62(d) (emphasis supplied).

Accordingly, pursuant to I.C.A.R. 62(c) and 62(d), IT IS HEREBY ORDERED THAT, effective immediately, both supplemental administrative and voir dire questionnaires are approved for use in the qualification of prospective jurors in the Third Judicial District of the State of Idaho. Said questions are attached as Exhibit A.
